

SUPPLY CONDITIONS

Prices

1) The prices quoted in price lists, spread by SIRA on paper or on magnetic media, must be considered in any case indicative.

2) The prices for goods are always delivered ex works of departure from our warehouse and don't include VAT, transportation and other additional expenses.

Orders

3) All orders sent to SIRA, are accepted under the conditions "for what is available and unless sold".

4) The orders relating to items not included in the catalog must be formalized by the Buyer in writing and equipped with everything necessary to fully describe the item without incurring in the cancellation of orders.

Delivery

5) The delivery time is always presumptive and remains subject to the availability of materials and labor, and any cases of circumstances beyond our control or for any case unavoidably.

6) If the delivery of ordered materials or articles should become impossible due to unavoidably cases or for circumstances beyond our control, SIRA may treat canceled all pending orders and commitments, without no obligation to pay any compensation of any kind.

7) The goods travel at one's risk of the buyer, even if sold ex works.

8) The buyer must check the goods upon delivery, to ensure the integrity of the delivered goods, both in terms of quality and quantity. Any complaints must be made in writing, directly with the contact of delivery and exactly at the time of delivery. In the case of transmission by carrier, such disputes will not be accepted unless confirmed by registered letter. It must be sent to the offices of SIRA in Verona within 2 days after delivery. We decline all responsibilities for all purposes of law, for any damage suffered by the commodity after its regular delivery.

Sales return

9) All delivered goods must be authorized by the Representative of SIRA. In any case, SIRA doesn't accept returns of articles or goods or any kind of our item after

60 days of delivery and however, any complaint must be explained not later than 7 days after delivery of the material. Likewise, SIRA doesn't accept returns for any material "procured" and materials "physically carried on design" and, more generally, for materials not included in the SIRA catalog.

Payments

10) The receipts issued to our representatives, such as commissions taken by themselves, are always accepted unless approved by the Management. Each receipted invoice does not prove that the payment itself and may not be used as a presumption of payment of previous invoices.

11) On late payments will be counted interests on arrears.

Agreements in exception

12) Any requirement of the buyer, different from the present conditions, will be accepted only if expressly agreed with SIRA in writing, and its validity is strictly limited to individuals and specific orders which were accepted. For any dispute, including payments, the court of Verona will have exclusive jurisdiction over any disputes relating to the terms and conditions mentioned above.
